With reference to the above, it is to inform that as per NCTE Regulations, 2014 a revised recognition order no. WRC/APW04034/323395/2015/148090 dt. 31.05.2015 was issued to the institution for conducting B.Ed. course of two year duration with an annual intake of 100 seats (two unit of 50 students) from session 2015-2016.

The WRC in its 292nd meeting held on May 15th - 17th, 2018 considered the reply dt. 11.05.2018 submitted by the institution, for compliance of conditions as mentioned in the revised recognition order dt. 31.05.2015 and decided as follows:-

"The case file was seen. Consequent to the appeal order, Clarification letter dated 03.05.2018 was issued.

The institution replied vide letter dated 11.05.2018. The institution has submitted the required staff profile approved by the Registrar.

Hence, permitted to continue."

Therefore, the revised recognition order no. WRC/APW04034/323395/2015/148090 dt. 31.05.2015 issued by the WRC for conducting B.Ed. course of two year duration with an annual intake of 100 students (two basic unit of 50 students) will remain continue.
